This role serves primarily a field oversight function but requires substantial technical/administrative work.

- Senior Supervisory Control and Data Acquisition (SCADA) Engineer  
Position will provide compliance oversight support to the project team to facilitate the acceptance of the Project into the Rail System. Role will be focused on oversight of SCADA systems work for compliance with Contract requirements. Primary function of this position will be field oversight but substantial technical/administrative work is required.
- Assistant Project Manager
